In accordance with PREA, all investigations are assigned one of three possible determinations:

Substantiated: an allegation which was investigated and determined to have occurred.

Unsubstantiated: an allegation which provided insufficient evidence to make a final determination of a substantiated or unfounded claim.

Unfounded: an allegation which was investigated and determined not to have occurred.

The chart below provides the annual results. No problem areas were identified and no corrective measures needed at this time.

Pamunkey Regional Jail makes every effort for reducing and/or eliminating sexual abuse and sexual harassment. This will be done by continuous inmate education along with staff training. Pamunkey Regional Jail will be scheduled for an audit later this year.
