INFORMATION:

- No kennel license or combination of licenses shall be issued for more than 50 dogs to be kept on any one tax map parcel unless a Special Exception Permit for a commercial kennel has been issued for that parcel pursuant to the Hanover County Zoning Ordinance. No releasing agency will be registered to keep more than 50 dogs unless a Special Exception Permit for a commercial kennel has been issued.
- Kennels (noncommercial or commercial) are not permitted in the following residential zoning districts: R-1, R-2, R-3, R-4, R-5, R-6, RS, RC (noncommercial kennels are permitted in the RC district in certain circumstances; call Planning for more information).
- A noncommercial kennel is a place prepared to house, board, breed, handle or otherwise keep or care for five (5) or more adult dogs.
- Noncommercial kennels are permitted in the A-1, AR-6 and AR-2 zoning districts provided that the applicant can locate the kennel at least two hundred (200) feet from side and rear property lines.
- A commercial kennel is a place prepared to house, board, breed, handle or otherwise keep or care for dogs for sale or in return for compensation.
- Commercial kennels are only permitted in the following zoning districts with a Special Exception Permit approved by the Board of Supervisors: A-1, AR-1, AR-2, AR-6, B-1, B-2, M-1. Contact Planning (365-6171) or Animal Control (365-6485) with any questions.
- Commercial kennels are permitted by-right in the following zoning districts: B-3, M-2, M-3. In the B-3 zoning district, kennels are required to be located at least two hundred (200) feet from any residential district.
- Applicants are required to indicate on the application if they intend to apply for a Commercial Kennel License.
- It is unlawful to own a dog four months old or older unless the dog is currently licensed.
- All applications are subject to review and may be deemed invalid if the kennel does not meet the standards set forth by Hanover County and Virginia State Law.
- A copy of the current rabies vaccination certificate must be presented for each dog, at the time of purchasing the kennel license.

I acknowledge that the information given on this application is correct. I understand that my kennel may be inspected by Animal Control to ensure compliance with Hanover County Code, and I consent to such inspection. I understand I will be contacted prior to such inspections. I understand that it is unlawful to keep more than 50 dogs on any one tax map parcel, unless a Special Exception Permit for a commercial kennel has been issued.
